TERMS AND CONDITIONS – MAJOR PRIZE PROMOTION – v2.0 20/05/2026

1. Entry into the Brisbane to Gold Coast Cycle for Cancer (B2GC) **Major Prize promotion** (“**Promotion**”) is deemed to be an acceptance of these Conditions of Entry. Information on how to enter the Promotion and prizes associated with the Promotion form part of these Conditions of Entry.
2. Entries for the Promotion commence at 00:01hrs AEST Thursday 30 April 2026 and close at 23:59hrs AEST Sunday 23 August 2026 (“**Promotion Period**”).
3. Entry is open to all B2GC participants who are residents of Queensland, Australia and over the age of 18 years at promotion commencement, on Thursday 30 April 2026 (“**Entrants**”).
4. Directors, officers, management, employees and other staff (and the immediate families of directors, officers, management, employees and other staff) of Mater Foundation and their related bodies corporate and agents are ineligible to enter.
5. The Promoter reserves the right in their sole discretion to disqualify any individual who the Promoter have reason to believe breached any of these conditions or engaged in any unlawful or otherwise improper misconduct calculated to jeopardise the fair and proper conduct of the competition. The Promoter's legal rights to recover damages or other compensation from such an offender are reserved.
6. To enter, Entrants must raise \$50.00 or more during the promotional period with funds raised displayed on their individual B2GC 2026 fundraising page at www.b2gc.com.au website. \$2,000 raised = 40 total maximum entries

Each valid entry received during the Promotion Period will be placed in the related Major Prize Draw.

8. Any Donation/s made by the Entrant, to the Entrant's own fundraising page (“**Self-donation/s**”) are excluded from eligibility in this Promotion.

14. The Major Prize Winners will be contacted by email and/phone with details of how to claim their prize.
15. Entries must be received by the Promoters within the Promotion Period. Entries are deemed to be received upon a verified donation being received to a participants individual fundraising page at www.b2gc.com.au during the promotion period.

16.11. Tickets must be issued on/before 31 March 2027. The Promoter will make all best efforts to remind the winner about the redemption timings of the Major Prize with EVA Air.

Tickets are valid for six (6) months from the date of issuance. Once ticket are issues, name change is not permitted. Tickets are not refundable. Tickets must be used in proper sequence. A no-show fee will be charged per ticket transaction per person.
