

Terms and Conditions - Mater UnCancer Smiddy Noosa Triathlon 2025 Expo Prize Draw

1. Entry into the Mater UnCancer Smiddy Noosa Triathlon 2025 Expo Draw ("**Promotion**") is deemed to be an acceptance of these Conditions of Entry. Information on how to enter the Promotion and prizes associated with the Promotion form part of these Conditions of Entry.
 2. Entries for the Promotion commence on 08:00hrs AEST Friday 31 October 2025 and close at 23:59hrs AEST Saturday, 1 November 2025 ("**Promotion Period**").
 3. Entry is open to all members of the public, who are both residents of Australia (excluding ACT) and over the age of 18 years on Wednesday 12 November 2025 ("**Entrants**").
 4. For clarity, this promotion is not open to residents of the ACT, as at Wednesday 12 November 2025.
