

**Terms and Conditions – Olivia’s Race Day
Canturi Raffle Prize Draw (Locked Box)**

21 March 2026

1. Entry into the Olivia’s Race Day (“**Canturi Jewel Raffle**”) is deemed to be an acceptance of these Conditions of Entry. Information on how to enter the Raffle and prizes associated with the Raffle form part of these Conditions of Entry.
2. Entry is open to Queensland residents (excluding those listed in point 3 of these conditions) from 29/01/2026 (“**Entrants**”)
3. Those who **CAN NOT** go in the prize draw include:
 - a) Members of management committee (Mater Foundation)
 - b) Person directly involved in conducting the draw (Mater Foundation)
 - c) Immediate family of the above (Mater Foundation)
4. The number of tickets available for sale is 500 and will be for sale and online at [<https://fundraise.mater.org.au/raffle/ord-canturi-26>] from 29/01/2026 and in person on 21/03/2026. Individuals may enter as many times as they like. Only tickets that have been paid for will be included in the draw.
5. Tickets are non-refundable and will be made available to the purchaser via email.
6. Entrants must be able to produce the winning ticket to claim the Raffle Prize Key. Entrants could win more than one key, based on having purchased multiple tickets in the Raffle.
7. The costs of the tickets are 1 for \$100, 3 for \$250 (must be purchased in one transaction).
8. There will be a total of 10 initial winners drawn by chance to receive a key (“**Key Winner**”).
 - a. Of the 10 Key Winners, One (1) Major Winner will have the correct key to be the overall Canturi Jewel Raffle winner (“**Major Prize Winner**”).
9. The prizes details:
 - The recommended retail value of the Major Prize is \$4,200.
10. The prize draw – 10 x Key Winners and 1x Major Prize Winner, will occur from approximately 2pm at the Olivia’s Race Day event at Eagle Farm Racecourse on 21/03/2026. The first key to unlock the prize will be the winner.
11. Entrants do not need to be present at the time of the prize draw. If the Prize Winner is present, they will take possession of the prize immediately. If not present, the Prize Winner will be notified by phone and email within 5 business days of the draw and arrangements made for handover of the prize.

 - a. The Promoter will make every reasonable effort and multiple attempts to locate the prize winners for the game and deliver the prizes to the winners on Day of Draw. The period for which unclaimed prizes to be kept is for one year from the day the prize winner is decided.
