Terms and Conditions Participant Registration for Point to Pinnacle 2022 with Mater Smiling for Smiddy

RECITALS

- A. Mater Foundation Ltd as trustee for Mater Foundation (ABN 96 723 184 640) 14 Stratton St, Newstead QLD 4006 ("Mater Foundation") is a registered Charity and owns the *Mater Smiling for Smiddy ("MS4S") fundraising program*.
- B. "Event" means the Point to Pinnacle 2022 to be held on 20 November 2022 in Hobart, Tasmania and any scheduled training sessions run by Smiling for Smiddy.
- C. The Mater Foundation's Smiling for Smiddy ("MS45") has secured entries to the event that we are permitted to on sell to people who commit to fundraise towards Mater Smiling for Smiddy.
- D. The **promoter and organiser of** Point to Pinnacle is THE RUNNING EDGE (ABN 51 708 599 162) 73 Murray St HOBART TAS 7000, Australia.
- E. "Claims" means all claims, liabilities, demands, suits, causes of action, damages, debts, costs, verdicts and judgments whatsoever whether at law or in equity or under any statute in connection with or arising out of the Event.
- F. "Releases" means Mater Foundation and any promoters, organisers, participants, sanctioning organizations, officials, rescue personnel, sponsors, advertisers, event inspectors, underwriters, consultants and any others who give recommendations or engage in risk evaluation regarding the Event.

SUBMISSION OF THIS FORM OR YOUR ACCEPTANCE OF THESE TERMS ELECTRONICALLY IS YOUR ACKNOWLEDGEMENT OF THE ACCEPTANCE OF THE TERMS & CONDITIONS OF PARTICIPATION IN THE EVENT.

1. Participant details

I wish to participate in the Event and understand that participation has inherent risks, including but not limited to risks to personal health arising from the physical nature of the Event, e.g. falling, tripping, risk of collision with vehicles and other objects etc.

2. Agreements for the Protection of Participants

6. Fee Refunds

If I am unable to participate in the Event after accepting these terms and conditions, I undertake to notify MS4S of my inability to participate at the earliest possible opportunity. I acknowledge that a cancellation fee will be incurred:

- 50% cancellation fee of the entry fee will be incurred if I withdraw up until 5.00pm Friday 5 August 2022
- 25% cancellation fee of the entry fee will be incurred if I withdraw up until 5.00pm Friday 16 September 2022
- I understand that I am not entitled to any refunds on my entry fee from requests received after 5.00pm Friday 16
 September 2022

7. Right to refuse application

I acknowledge that Mater Foundation reserves the right to refuse my application to register. Should my application be refused my full registration fee will be refunded to me.

8. Travel Expenses

I understand that my entry fee does not include travel to and from the event, nor does it include accommodation in Hobart. All travel arrangements and related expenses are my responsibility.
