

## Terms and Conditions

### Participant Registration for Point to Pinnacle 2022 with Mater Smiling for Smiddy

Entry into Point to Pinnacle 2022 with Mater Foundation's program "Mater Smiling for Smiddy" is deemed to be an acceptance of Terms and Conditions of Entry.

#### RECITALS

- A. Mater Foundation Ltd as trustee for Mater Foundation (ABN 96 723 184 640) 14 Stratton St, Newstead QLD 4006 ("**Mater Foundation**") is a registered Charity and owns the *Mater Smiling for Smiddy* ("**MS4S**") fundraising program.
- B. "**Event**" means the Point to Pinnacle 2022 to be held on 20 November 2022 in Hobart, Tasmania and any scheduled training sessions run by Smiling for Smiddy.
- C. The Mater Foundation's Smiling for Smiddy ("**MS4S**") has secured entries to the event that we are permitted to on sell to people who commit to fundraise towards Mater Smiling for Smiddy.
- D. The **promoter and organiser of** Point to Pinnacle is THE RUNNING EDGE (ABN 51 708 599 162) 73 Murray St HOBART TAS 7000, Australia.
- E. "**Claims**" means all claims, liabilities, demands, suits, causes of action, damages, debts, costs, verdicts and judgments whatsoever whether at law or in equity or under any statute in connection with or arising out of the Event.
- F. "**Releases**" means Mater Foundation and any promoters, organisers, participants, sanctioning organizations, officials, rescue personnel, sponsors, advertisers, event inspectors, underwriters, consultants and any others who give recommendations or engage in risk evaluation regarding the Event.

SUBMISSION OF THIS FORM OR YOUR ACCEPTANCE OF THESE TERMS ELECTRONICALLY IS YOUR ACKNOWLEDGEMENT OF THE ACCEPTANCE OF THE TERMS & CONDITIONS OF PARTICIPATION IN THE EVENT.

#### 1. Participant details

I wish to participate in the Event and understand that participation has inherent risks, including but not limited to risks to personal health arising from the physical nature of the Event, e.g. falling, tripping, risk of collision with vehicles and other objects etc.

#### 2. Agreements for the Protection of Participants

- I am aware that as a participant of the Event, I and my possessions are not covered by Mater Foundation's insurance.
- I agree to take full responsibility and assume liability for any and all costs incurred as a result of my participation in the Event.
- I acknowledge that THE RUNNING EDGE have instituted its rules and safety procedures for the protection of the participant and co-participants. I confirm that prior to participating in the Event I will familiarise myself with those rules and safety procedures and follow them throughout the event. I also recognise the authority of the Mater Foundation and/or THE RUNNING EDGE personnel to halt my participation (and, if necessary, have me removed from the course and premises) conduct, or presence endangers myself or my co-participants.
- I understand that as part of my event registration with MS4S, I will need to register my participation with THE RUNNING EDGE using the THE RUNNING EDGE link provided to me by Mater Foundation. As part of that registration, I will agree and adhere by the terms and conditions as outlined by THE RUNNING EDGE®. If I fail to complete the THE RUNNING EDGE registration link by the deadline provided to me, I understand that it will forfeit my participation in the Point to Pinnacle 2022 and I will forfeit my registration fee in its entirety.
- THE RUNNING EDGE require approvals to hold a COVID-safe event. Should the Point to Pinnacle 2022 not gain approval to proceed as advertised, Mater Foundation will advise participants of the impacts accordingly.

#### 3. Waiver of Liability and Indemnification

In consideration of MS4S accepting my entry into the Event, I absolutely release and waive any claim I might otherwise have had against Mater Foundation and any officials or volunteers associated with the Event in respect of any injury, loss or damage I might suffer arising from my participation in the Event, including any loss or damage arising from a breach of contract and/or negligence by Mater Foundation or any Event officials or volunteers.

I will also indemnify and hold harmless Mater Foundation against any loss or damage claimed against it by third parties as a result of any such claim made by me during the Event or arising from any action or negligence caused by me during the Event.

#### 4. Traffic & Road Laws

I agree to follow all traffic and road laws including directions by Police, THE RUNNING EDGE®, Mater Foundation staff and volunteers. I understand that failure to do so may result in my being removed from the Event.

## **5. Fundraising**

I acknowledge that acceptance of this entry form and registration to take part in the Event carries with it an obligation to meet a fundraising target of A\$1,500. I commit to fundraising A\$1,500 and accept that my failure to do so by 5.00pm on 18 November 2022 will grant Mater Foundation the right to issue an invoice with the shortfall.

I understand that my failure to lodge the fundraising target may render me ineligible to participate in and I may forfeit my entry and associated entry fee.

I understand that all donations processed by Mater Foundation are non-transferable and non-refundable, even if I do not participate in the event.

## **6. Fee Refunds**

If I am unable to participate in the Event after accepting these terms and conditions, I undertake to notify MS4S of my inability to participate at the earliest possible opportunity. I acknowledge that a cancellation fee will be incurred:

- 50% cancellation fee of the entry fee will be incurred if I withdraw up until 5.00pm Friday 5 August 2022
- 25% cancellation fee of the entry fee will be incurred if I withdraw up until 5.00pm Friday 16 September 2022
- I understand that I am not entitled to any refunds on my entry fee from requests received after 5.00pm Friday 16 September 2022

## **7. Right to refuse application**

I acknowledge that Mater Foundation reserves the right to refuse my application to register. Should my application be refused my full registration fee will be refunded to me.

## **8. Travel Expenses**

I understand that my entry fee does not include travel to and from the event, nor does it include accommodation in Hobart. All travel arrangements and related expenses are my responsibility.

## **9. Media and photography**

I hereby grant to Mater Foundation the right, permission, and authority to use my name, image, voice, and/or likeness, without compensation, captured during the Event and its affiliated entities or contractors, and/or the media in any photographs, videotapes, CDs, DVDs, broadcast, telecast, podcast, webcast, recordings, motion pictures, commercial advertisement, promotion materials, and/or any other record of the Event for any purpose whatsoever.

I acknowledge my personal information, including photos, is collected, held and used by Mater Foundation for event coordination and administration purposes, Mater Foundation event marketing and Mater Foundation fundraising activities. THIS WAIVER AND RELEASE SHALL BE INTERPRETED AND THE RIGHTS OF THE PARTIES DETERMINED UNDER THE LAW OF QUEENSLAND. THE QUEENSLAND COURTS SHALL HAVE EXCLUSIVE JURISDICTION FOR ANY DISPUTE ARISING UNDER, OR PERTAINING TO, THIS WAIVER AND RELEASE.
