



Terms and Conditions – *Get a donation to win promotion*

Eligibility Period:

- Starts **00:01 AEST on Monday, 16 February 2026** and ends at **23:59 AEST on Friday, 20 February 2026**

How It Works:

- Receive a donation to a 2026 Smiddy Noosa Tri event fundraising page via the official website <https://fundraise.mater.org.au/event/noosatri-2026>
- Ensure the donation receives a donation receipt.
- Each donation of any amount will be one entry into the draw.

Notifications:

- Mater Foundation will contact the winners within 5 days of the draw date. Details of the winner will be published on <https://fundraise.mater.org.au/event/noosatri-2026> following the draw.

1. Entry into the Smiddy Noosa Tri 2026 (NT26) ***Get a donation to win promotion*** ("**Promotion**") is deemed to be an acceptance of these Conditions of Entry. Information on how to enter the Promotion and prizes associated with the Promotion form part of these Conditions of Entry.

The Promoter reserves the right in their sole discretion to disqualify any individual who the Promoter have reason to believe breached any of these conditions or engaged in any unlawful or otherwise improper misconduct calculated to jeopardise the fair and proper conduct of the competition. - 15.1. The value of the prize pool is accurate at the date of commencement of the Promotion Period. The Promoter accepts no responsibility for any variation in the value of the Prize after that date.
- 15.2. The Prize cannot be transferred, exchanged or redeemed for cash.
- 15.3. The Promoter's decision is final and no correspondence will be entered into, including in the event of a dispute.
- 15.4. If a purchase exceeds the face value of the voucher, you must make up the difference with another payment method; you are liable for all transactions on your voucher.

The Promoter will not be liable for any loss or damage whatsoever which is suffered, including but not limited to indirect or consequential loss, or for any personal injury suffered or sustained as a result of receiving, taking or using any Prize except for any liability which cannot be excluded by law.
