## Terms and Conditions – RACQ International Women's Day Fun Run 2022

## 'Drive your Fundraising' promotion

- Entry into the RACQ International Womens' Day Fun Run event 2022 (IWDFR) Drive your Fundraising promotion ("Promotion") is deemed to be an acceptance of these Conditions of Entry. Information on how to enter the Promotion and prize associated with the Promotion form part of these Conditions of Entry.
- 2. The Promotion operates under the following permit numbers ACT: TP 21/02041.1 and NSW: NTP/02985.
- 3. The Promoter in all States and Territories is Mater Foundation Limited, 14 Stratten Street, Newstead, 4006 (ABN 96 723 184 640) (The Promoter).
- 4. Entries for the Promotion commence at 00:00hrs AEST Wednesday 1 December 2021 and close at 23:59hrs AEST Friday 4 March 2022 ("**Promotion Period**").
- 5. Entry is open to all IWDFR participant registration types ("Entrants").
- 6. Residents of South Australia are not eligible to enter.
- 7. Directors, officers, management, employees and other staff (and the immediate families of directors, officers, management, employees and other staff) of Mater Foundation and their related bodies corporate and agents are ineligible to enter.
- 8. Directors, officers, management, employees and other staff (and the immediate families of directors, officers, management, employees and other staff) of Sime Darby Motors Group Australia Pty Ltd and their related bodies corporate, entities and agents are ineligible to enter.
- 9. Directors, officers, management, employees and other staff (and the immediate families of directors, officers, management, employees and other staff) of RACQ Operations Pty Ltd and their related bodies corporate, entities and agents are ineligible to enter.

For example: If \$100 or more is raised for the first time on Friday 4 December, only one entry will be granted.

- 12. Each valid entry received during the Promotion Period will be placed in the related Major Prize Draw.
- 13. There is a maximum of two (2) entry per Entrant.
- 14. There is a total of one major prize winner ("Major Prize Winner)
