# Terms and Conditions – Team Smiddy at Noosa Triathlon

# Fundraise to win promotion

- 1. Entry into the Team Smiddy at Noosa Triathlon (TSNT) *Get a donation to win promotion* ("**Promotion**") is deemed to be an acceptance of these Conditions of Entry. Information on how to enter the Promotion and prizes associated with the Promotion form part of these Conditions of Entry.
- 2. Entries for the Promotion commence at 00:01hrs AEST Tuesday 27 July 2021 and close at 11:59hrs AEST Friday 30 July 2021 ("**Promotion Period**").
- 3. Entry is open to all Team Smiddy at Noosa Triathlon participants ("Entrants").
- 4. Directors, officers, management, employees and other staff (and the immediate families of directors, officers, management, employees and other staff) of Mater Foundation and their related bodies corporate and agents are ineligible to enter.
- 5.
