

## Terms and Conditions - Smiddy at Noosa Triathlon

### Register to win your Smiddy at Noosa Triathlon 2026 registration fee back

1. Entry into the Smiddy at Noosa Triathlon 2026 'Register to win your Smiddy at Noosa Triathlon fee back' draw ("**Promotion**") is deemed to be an acceptance of these Conditions of Entry. Information on how to enter the Promotion and prizes associated with the Promotion form part of these Conditions of Entry.
2. Entries for the Promotion commence on 08:00hrs AEST Thursday 13 November 2025 and close at 23:59hrs AEST Sunday 30 November 2025 ("**Promotion Period**").
3. Entry is open to all members of the public ("**Entrants**").
4. Directors, officers, management, employees and other staff (and the immediate families of directors, officers, management, employees and other staff) of Mater Foundation and their related bodies corporate and agents are ineligible to enter.
5. The Promoter reserves the right in their sole discretion to disqualify any individual who the Promoter have reason to believe breached any of these conditions or engaged in any unlawful or otherwise improper misconduct calculated to jeopardise the fair and proper conduct of the competition.   - d) Remain entered as a Smiddy at Noosa Triathlon 2026 participant as at the close of the 'promotional period'.
7. Each valid entry received during the Promotion Period will be placed in the Major Prize Draw.
8. There is a total of one (1) prize winners consisting of one Major Prize Winner ("**Major Prize**").
