

Terms and Conditions – International Women's Day Fun Run 2024

Raise \$48 in 48 Hours Promotion

1. Entry into the International Womens' Day Fun Run 2024 (IWDFR) **Raise \$48 in 48 Hours Promotion** ("Promotion") is deemed to be an acceptance of these Conditions of Entry. Information on how to enter the Promotion and prizes associated with the Promotion form part of these Conditions of Entry.
2. Entries for the Promotion commence at 10:00hrs AEST Wednesday 21 February 2024 and close at 9:59hrs AEST Friday 23 February 2024 ("**Promotion Period**").
3. Entry is open to IWDFR participants ("**Entrants**") who are aged 18 years or older on 23 February 2024.
4. Directors, officers, management, employees and other staff (and the immediate families of directors, officers, management, employees and other staff) of Mater Foundation and their related bodies corporate and agents are ineligible to enter.
