

## Terms and Conditions – International Women's Day Fun Run 2024

2. Entries for the Promotion commence at 00:01hrs AEST Tuesday 9 January 2024 and close at 23:59hrs AEST Sunday 3 March 2024 ("**Promotion Period**").
3. Entry is open to all IWDFR participants ("**Entrants**") who are over the age of 18 years on Sunday 10 March 2024. Residents of South Australia, and Western Australia are not eligible to enter.
4. The Promotion operates under the following permit number- ACT: TP 23\_02690
