

# Terms and Conditions – International Women's Day Fun Run 2024

## Win a Getaway with your Breastie's Promotion

1. Entry into the International Women's Day Fun Run 2024 (IWDFR) **Win a Getaway with your Breasties Promotion** ("Promotion") is deemed to be an acceptance of these Conditions of Entry. Information on how to enter the Promotion and prizes associated with the Promotion form part of these Conditions of Entry.
2. Entries for the Promotion commence at 00:01hrs AEST Wednesday 6 December 2023 and close at 23:59hrs AEST Sunday 10 March 2024 ("Promotion Period").
3. Entry is open to all IWDFR participants ("Entrants") who are over the age of 18 years on Sunday 10 March 2024. Residents of South Australia, and Western Australia are not eligible to enter.
4. The Promotion operates under the following permit number- ACT: TP 23\_02411.1
5. Directors, officers, management, employees and other staff (and the immediate families of directors, officers, management, employees and other staff) of Mater Foundation and their related bodies corporate and agents are ineligible to enter.
6. The Promoter reserves the right in their sole discretion to disqualify any individual who the Promoter have reason to believe breached any of these conditions or engaged in any unlawful or otherwise improper misconduct calculated to jeopardise the fair and proper conduct of the competition. The Promoter's legal rights to recover damages or other compensation from such an offender are reserved.
7. To enter, Entrants must raise \$50 or more during the promotion period and this total be visible on their Fundraising Page on the International Women's Day Fun Run 2024 website ([www.womensdayfunrun.org.au](http://www.womensdayfunrun.org.au)) during the promotion period.
  - 7.1. The final number of entries per Entrant will be calculated in \$50 increments in accordance with the total fundraising amount visible on each entrant's fundraising page as at the end of the Promotion Period.
  - 7.2. Entries will be applied based on the fundraising amount achieved at 23:59hrs AEST Sunday 10 March 2024, as set out below:
    - 7.2.1. For example:
      - \$50 raised = 1 entry.
      - \$75 raised = 1 entry.
      - \$200 raised = 4 total entries.
      - \$500 raised = 10 total entries.
      - \$1,500 raised = 30 total entries.
      - \$2,000 raised = 40 total maximum entries
- Each valid entry received during the Promotion Period will be placed in the related Major Prize Draw.
- 7.3. Multiple entries are permitted, with the maximum number of entries being forty (40). Refer Clause 7.2.1.
- 7.4. There is a total of one major prize winner ("**Major Prize Winner**")

  - Four nights' accommodation in a **luxury villa at Yangaro Resort** (Funnel Bay, Queensland) up to the value of \$6,500.

9. The Major Prize Winners will be advised within five (5) business days of the draw and their name may be published on [www.womensdayfunrun.com.au](http://www.womensdayfunrun.com.au)
10. The Major Prize Winners will be contacted by phone and email with details of how to claim their prize.
11. Entries must be received by the Promoters within the Promotion Period. Entries are deemed to be received upon a verified donation being received to a participant's fundraising page at [www.womensdayfunrun.com.au](http://www.womensdayfunrun.com.au) during the promotion period.

## **12. Prizes**

13. The value of the prize pool is accurate at the date of commencement of the Promotion Period. The Promoter accepts no responsibility for any variation in the value of the Prize after that date.
14. The Promoter will pay the major prize winners' mandated \$2,000 resort deposit, which will be refunded to The Promoter upon the winners' completion of their resort stay. Any damages to the property identified and directed by Yangaro Resort (Terms & Conditions), above the resort deposit will be payable to and dealt directly with Yangaro Resort by the major prize winner.
15. The Prize cannot be transferred, exchanged, redeemed for cash. Refer Clause 7.5 for more information. The prize must be taken in one booking.
16. The Promoter's decision is final and no correspondence will be entered into, including in the event of a dispute.
17. If a purchase exceeds the face value of the voucher, you must make up the difference with another payment method; you are liable for all transactions on your voucher.
18. If for any reason the prize is not used by the expiry date identified on the voucher/s, the prize, or any remaining portion of the prize will be forfeited. Voucher will be valid for 1 year from draw date. If a winner does not use the full 4 nights' accommodation voucher, the remaining credit can be used as resort credits in the same booking.
19. The Promoter accepts no responsibility for lost or stolen vouchers.
20. Major Prize Winner Yangaro Resort prize package: If they are unable to redeem a Flight Centre gift voucher in store per Clause 7.5, the available substitute will be an equivalent travel booking voucher with an alternative provider arranged by the Promoter.

Where Mater Foundation is unable to verify or contact a winner or any prize remains unclaimed after all reasonable attempts have been made to locate or otherwise contact the winner, the prize will be held for 2 months, after which time the Promoter will hold an unclaimed prize draw to select an alternative winner. The unclaimed prize draw will be held at 11:00 AEST, Wednesday 22 May 2024 at 14 Stratton Street, Newstead, 4006 or remotely by Microsoft Teams. The alternative winner will be notified in writing within 5 days of the unclaimed prize draw about the amount of the prize and of the time and place at which it may be collected.

- 22.1. The Promoter reserves the right to validate and check the authenticity of entries and to disqualify any entrant for tampering with the entry process.
- 22.2. The Promoter and its associated agencies or companies accept no responsibility for lost, late, stolen, damaged or misdirected entries.
- 22.3. The Promoter has no control over internet or mobile telecommunications, network lines, bugs, viruses or server problems, and accepts no responsibility for any problems associated with them, for whatever reason.
- 22.4. Any entry that is lodged by automatic, repetitive, robotic, programmed or similar methods will be deemed void as determined in the absolute discretion of the Promoter.
- 22.5. All entries become the property of the Promoter.

## **23. No Liability**

- 23.1. If any act or omission, event or circumstance occurs which is beyond the reasonable control of the Promoter and which prevents the Promoter from complying with these Conditions of Entry, the Promoter will not be liable for any failure to perform or any delay in performing its obligations.
- 23.2. The Promoter reserves the right, subject to any applicable law, to cancel, terminate, modify or suspend the Promotion.
- 23.3. The Promoter will not be liable for any loss or damage whatsoever which is suffered, including but not limited to indirect or consequential loss, or for any personal injury suffered or sustained as a result of receiving, taking or using any Prize except for any liability which cannot be excluded by law.
- 23.4. The Promoter accepts no responsibility for any tax liability incurred as a result of participating in this Promotion. Any tax liability arising as a result of accepting any Prize is the responsibility of the Winner.

## **24. Consent**
