

Terms and Conditions – Golf for Miracles

 - c) Immediate family of the above (Mater Foundation)
- The number of tickets available for sale is 120 and will be for sale in-person on 09/05/2025 and online at <https://fundraise.mater.org.au/raffle/gfm25-hv>. Individuals may enter as many times as they like. Only tickets that have been paid for will be included in the draw.
4. Tickets are non-refundable and will be made available to the purchaser via e-mail.
 5. Entrants must be able to produce the winning ticket to claim the prize.
 6. The costs of the tickets are 1 for \$100, and 7 for \$500
